- 1.1. All qualifications should have been acquired from Indian Universities/Institutes, recognized by UGC or AICTE (whichever is applicable) or any other appropriate statutory authority in India.
- 1.2. Candidates belonging to EWS, OBC (NCL) & SC/ST categories should meet the eligibility norms notified for Unreserved (UR) category for consideration against UR vacancies. In other words, OBC (NCL) & SC/ST candidates will be considered against Unreserved posts only if they fulfill the qualifying criteria for UR category.
- 1.3. The courses will be conducted on full time basis at the Location / Centres notified under para 1.0 (Trichy / Vellore / Bangalore).
- 1.4. The program is fully residential. Candidates will be provided Hostel facility at the Training Centres of NTTF at free of cost (The cost shall be borne by NLCIL). Hence, candidates have to stay at the hostels provided and undergo the training program on full time basis and adhere to the rules & regulations of the NTTF Institute.

3.0 Crucial Date:

Crucial date for determination of upper age limit is 01-01-2025.

4.0 Reservations and Relaxation:

- 4.1. Reservation for EWS, OBC (NCL) & SC/ST candidates will be as per the GOI guidelines.
- 4.2. OBC Candidates belonging to “Creamy Layer” are not entitled to avail any concession otherwise extended to OBC (Non-Creamy Layer) category. Such candidates have to indicate their category as UR.
- 4.3. Candidates belonging to OBC (NCL) category should enclose valid OBC (NCL) certificate in the prescribed format (applicable for purpose of reservation in appointment to posts under Government of India as contained in DOPT Memo No.36036/2/2013-Estt.(Res.) dated 30-05-2014) obtained from competent authority. However, at the time of selection, they should produce OBC (NCL) certificate obtained on or after 01.04.2023 from competent authority failing which, they will not be considered under OBC (NCL) category.
- 4.4. Candidates belonging to EWS, OBC (NCL) and SC/ST are required to submit requisite certificate in the format prescribed by Government and issued by the Competent Authority.
- 4.5. Candidates belonging to Economically Weaker Sections (EWS) will have to furnish self-attested copy of valid Income & Asset certificate issued by the competent authority as per OMNo.36039/1/2019 – Estt. (Res) dated 31.01.2019 of DoPT, Ministry of PPG&P, Govt. of India. However, at the time of selection, they should produce Income and Asset Certificate for Economically Weaker Sections obtained on or after 01.04.2023 from competent authority failing which, they will not be considered under EWS category.
- 4.6. Category (EWS, OBC (NCL) & SC/ST) once filled in the application form will not be changed and no benefit of other category will be admissible later on.

5.0 Criterion for consideration under PAP category:

- 5.1. The Project Affected Persons from the families who have surrendered lands /house sites for Neyveli projects of NLCIL alone are eligible.
- 5.2. Only one member of the Project Affected Family is eligible for the training program at NTTF.
- 5.3. Candidates from Project affected families pertaining to the lands / house awards passed on or after 01-07-1989 are only eligible to apply under PAP category.
- 5.4. Awardees should have handed over the land/ house with house site to NLCIL.
- 5.5. Applicant should be an awardee or a nominated person from his/her family.
- 5.6. An awardee must be a land owner (Pattadar /Document holder). An awardee can also nominate any one of the family members who can be either himself / herself, (or) his/her Spouse (or) Son/Daughter (or) Son-In-Law /Daughter-in-Law (or) Grand-Son/Grand-Daughter, subject to production of Notarized Affidavit for Consent from other family members of the awardee.
- 5.7. When the awardee is no more, one of the legal heirs of the awardee is eligible to apply subject to production of Notarized Affidavit for Consent from all other legal heirs and death certificate and legal heir certificate of the awardee.
- 5.8. If husband and wife are awardees, only one member from the family is eligible to apply.
- 5.9. If the awardee does not have descendant, legally adopted Son/Daughter is eligible to apply subject to production of valid documents.

- 5.10. An awardee who has purchased the property (Lands/House) on or after the 3(2)-notification date and acquired by NLCIL are not eligible to apply under PAP quota.
- 5.11. Settlers in Government Lands are not eligible to apply under PAP quota.

6.0 Proof in support of Project Affected Persons:

Candidates must attach /produce the following documents/ certificates to establish the status of PAP.

- 6.1 . PAP Eligibility Certificate in the prescribed format (enclosed) issued by the Head of Land Department, NLCIL, Neyveli, should be submitted along with application and produce the original award copy at the time of verification of documents.
- 6.2 . If the awardee is alive, Notarized Affidavit for Consent from Awardee & family members in favour of the applicant shall be submitted for availing the benefit (format enclosed).
- 6.3 . If the awardee is not alive, the death certificate of awardee, legal heir certificate and Notarized Affidavit for Consent from all other legal heirs in favour of the applicant shall be submitted for availing the benefit (format enclosed).
- 6.4 . The PAPs who are furnishing True Certificate issued by DRO instead of original 12(2) Notice and PAPs who have lost their original 12(2) Notice and complied with the established procedures like registering their complaint in police station & obtaining non-traceable certificate, will also be considered for allocation of seat.

7.0 Method of selection of Candidates:

- 7.1. Selection of applicants for the course shall be based on the % of Mark/ CGPA scored in the notified qualifying examination.
- 7.2. In case of tie at cut-off level, (i.e.) more than one candidate scored same % of Marks/ CGPA, in such cases tie will be resolved by applying the following criteria, one after another, till the tie is resolved:
 - 7.2.1. Date of award (earlier date of award shall be given priority).
 - 7.2.2. Land extent (higher extent of land shall be given priority).
 - 7.2.3. Date of Birth of the candidates, senior most candidate(s) by age will be placed higher.

8.0 Allocation of Seats:

- 8.1. 25% of the seats for the course will be allocated in respect of awardees for whom the awards have been passed from 01.07.1989 to 31.12.2013.
- 8.2. 25% of the seats for course will be allocated in respect of awardees for whom the awards have been passed from 01-01-2014 to 30-06-2022.
- 8.3. 50% of the seats for course will be allocated in respect of awardees for whom the awards have been passed from 01-07-2022 onwards.
- 8.4. Awardees of land whose awards passed on or after 01-07-1989 only are eligible to apply under PAPs.
- 8.5. If sufficient candidates are not available in the respective seats (i.e., Award period), candidates will be selected based on the qualifying marks irrespective of date of passing of award (swapping among slots shall be considered).
- 8.6. Alphabetical order of first name of the candidates.

9.0 General Information:

- 9.1. Depending on the response and requirement, NLCIL reserves the right to relax the eligibility conditions and to swap the seats between the categories.
- 9.2. NLCIL reserves the right to cancel / restrict / enlarge / modify / reopen / alter the selection process if the need so arises without issuing any further notice or assigning any reasons thereof.
- 9.3. Candidates are informed that mere submission of applications shall not give them any right to be called for Selection. NLCIL reserves the right not to fill up any or all the seats notified at its discretion.
- 9.4. NLCIL reserves its right to terminate continuation of the candidate from the course, if, in the opinion of NTTF / TNSDC / NLC India, the candidate is not subjecting himself to proper and disciplined training. However, the decision of NLCIL shall be final and binding in this regard.
